1 for the Court to consider the motion [ECF No. 339] (“Procedure Motion”) filed by the Debtor for
2 entry of an order approving the Debtor’s first amended disclosure statement [ECF No. 338], as well
3 as various procedures related thereto.

4 **PLEASE TAKE FURTHER NOTICE** that pursuant to the OST App, the Debtor is
5 requesting that the Court **set September 23, 2022 as the deadline to object to the Procedure**
6 **Motion**. You will receive a copy of the order on the OST App once it has been entered by the
7 Court.

8 **PLEASE TAKE FURTHER NOTICE THAT** a copy of the Procedure Motion may be
9 obtained from the above-captioned Court, located at the Foley Federal Building, 300 Las Vegas
10 Blvd. South, Las Vegas, Nevada 89101, through the Court’s electronic filing system
11 (<https://ecf.nvb.uscourts.gov/>), for free via the Debtor’s noticing agent at
12 <https://cases.stretto.com/FrontSight> or by sending a written request to counsel for the Debtor, Susan
13 K. Seflin, via email at sseflin@bg.law.

15 If you object to the relief requested, you *must* file a **WRITTEN** response to the Procedure
16 Motion with the Court. You *must* also serve your written response on the person who sent you
17 this notice.

18 If you do not file a written response with the Court, or if you do not serve your written
19 response on the person who sent you this notice, then:

- 20 • The Court may *refuse to allow you to speak* at the scheduled hearing; and
- 21 • The Court may *rule against you* without formally calling the matter at the hearing.
