

**JONES LOVELOCK** 6600 Amelia Earhart Court, Suite C Las Vegas, Nevada 89119 jointly request that LVDF's Motion to Quash and/or Protective Order be taken off calendar.

2 On July 29, 2022, LVDF and Mr. Dziubla filed a motion to quash 2004 exams and subpoenas to 3 produce documents and request for a protective order ("Motion to Quash"). See, ECF No. 309.

4 On September 1, 2022, this Court heard arguments on the Motion to Quash, requested that the Parties meet and confer again and report back to the Court on or before September 9, 2022. See, 6 ECF No. 333.

7 On September 7, 2022, the Parties had a productive meet and confer and on September 7, 2022, 8 submitted their first Joint Status Report, requesting that the Court continue the Motion to Quash to 9 September 30, 2022 at 9:30 a.m., for status only. See, ECF No. 335. The Parties had a subsequent 10 meet and confer on September 21, 2022 and, at that time, Debtor agreed to withdraw its Subpoenas 11 for Documents to LVDF and Mr. Dziubla as well as its requests for 2004 exams of LVDF and Mr. Dziubla. Debtor is withdrawing its Subpoenas and 2004 exams without prejudice and reserving the 12 13 right to issue new subpoenas and/or deposition notices once its objection to LVDF's claim is on file. 14 In light of Debtor's decision to withdraw the Subpoenas and 2004 exams, the parties agree that 15 LVDF's Motion to Quash be withdrawn. The parties' reserve their rights to address any future 16 subpoenas, 2004 exams and/or deposition notices.
