**CERTIFICATION OF ADAM J. FIALKOWSKI OF STRETTO REGARDING VOTING
AND TABULATION OF BALLOTS CAST ON THE DEBTOR’S SECOND AMENDED
CHAPTER 11 PLAN OF REORGANIZATION**

I, Adam J. Fialkowski, declare, under penalty of perjury:

1. I am a Director of Stretto, the claims and noticing agent retained in the above-captioned bankruptcy case of Front Sight Management LLC (the “Debtor”). I am over the age of eighteen years. I do not have a direct interest in the chapter 11 case and should be considered an impartial party. Except as otherwise indicated, all matters set forth herein are based upon my personal knowledge, and, if called as a witness, I could and would testify competently thereto.

2. I submit this certification (the “Certification”) with respect to the solicitation and tabulation of votes cast on the *Debtor’s Second Amended Chapter 11 Plan of Reorganization* (as may be amended or modified, the “Plan”)¹. Except as otherwise indicated herein, all facts set forth herein are based upon my personal knowledge or my review of relevant documents. I am authorized to submit this Certification on behalf of Stretto. If I were called upon to testify, I could and would testify competently as to the facts set forth herein.

3. In accordance with (a) the *Order Granting Debtor’s Emergency Application for the Entry of an Order Authorizing the Debtor to Employ and Retain Stretto as Claims , Noticing and Solicitation Agent*, dated June 1, 2022 [Docket No. 64] and (b) the *Order Approving (I) Adequacy*

1 of Debtor's Second Amended Disclosure Statement (As may be Further Amended or Modified);
 2 (II) Approving Solicitation Procedures, Manner of Notice and Vote Tabulation Procedures;
 3 Manner of Notice and Vote Tabulation Procedures; (III) Establishing Voting Record Date, and
 4 Deadline for Receipt of Ballots; and (IV) Fixing Date, Time and Place for Confirmation Hearing
 5 and (V) Setting Deadline to File Objections to Confirmation, dated October 3, 2022 [Docket No.
 6 403] (the "Disclosure Statement Order"), Stretto was appointed and authorized to assist the Debtor
 7 with, inter alia, soliciting, receiving, reviewing, determining the validity of, and tabulating Ballots
 8 cast on the Plan by holders of Claims in the Voting Classes (as defined below).
 9

11 4. The Disclosure Statement Order established September 30, 2022 as the record date
 12 for determining the Holders of Claims in the Voting Classes who would be entitled to vote on the
 13 Plan (the "Voting Record Date"). The Disclosure Statement Order extended the Voting Record
 14 Date through November 4, 2022 for Active Members² who filed Proofs of Claim on or prior to the
 15 Voting Deadline of November 4, 2022.

16 5. Pursuant to the Plan and Disclosure Statement Order, only Holders of Claims in the
 17 following classes as of the Voting Record Date, were entitled to vote to accept or reject the Plan
 18 (the "Voting Classes"):

Classes	Class Description
Class 1	Secured Claim of Las Vegas Development Fund
Class 2	Secured Claim of Michael Meacher DBA Bankgroup Financial Services
Class 3	M2 EPC
Class 4	Top Rank Builders, Inc./Morales Construction
Class 6	General Unsecured Claims

27 ² Active Members, as defined in the Disclosure Statement Order [Docket No. 403], consist of all members who spent money on their membership and membership benefits (Approximately 77,000 people) in accordance with the Debtor's Books and Records.

1 No other classes under the Plan were entitled to vote on the Plan.

2 6. The procedures for the solicitation and tabulation of votes on the Plan are outlined
3 in the Disclosure Statement Order. In accordance with the Disclosure Statement Order, Stretto
4 worked closely with the Debtor’s professionals to identify the holders entitled to vote in the Voting
5 Classes as of the Voting Record Date, and to coordinate the distribution of solicitation materials
6 to these holders. Stretto was instructed by the Debtor to solicit, review, determine the validity of,
7 and tabulate Ballots submitted to vote to accept or reject the Plan by the Holders of Claims in the
8 Voting Classes.

9 7. On or before October 7, 2022, pursuant to and in accordance with the Disclosure
Statement Order, Stretto caused the Solicitation Packages (including the ballots where applicable)
to be served on the Holders of Claims in the Voting Classes as of the Voting Record Date. A
11 detailed description of Stretto’s distribution of solicitation materials is set forth in Stretto’s
12 *Certificate of Service* filed with the Court on October 18, 2022. [Docket No. 424]

13 8. Subsequent Solicitation Packages were periodically served on Holders of Claims
14 entitled to vote on the plan. Additional certificates evidencing Stretto’s supplemental services in
15 accordance with the Disclosure Statement Order were filed with the Court [Docket Nos. 447, 448,
16 460, 467, 485, 500 and 516]

17 9. Stretto promptly complied with all requests for additional or replacement
18 solicitation materials and/or (in the case of parties entitled to vote) Ballots.

19 10. Copies of the Plan, Disclosure Statement, Confirmation Hearing Notice [Docket
20 No. 407], and Rejection Bar Date Notice [Docket No. 408] were made available (free of charge)
21 at <https://cases.stretto.com/FrontSight> on October 3, 2022

22 11. Ballots returned by online submission, mail, hand delivery, or overnight courier
23 were received by personnel of Stretto at the offices of Stretto in Irvine, California. All Ballots
24 received by Stretto were date-stamped upon receipt. Each Ballot was then scanned into Stretto’s
25 system and sequentially numbered (the “Ballot Number”). Stretto then entered into a computer

1 database all pertinent information from each of the Ballot, including among other things, the date
2 and time the Ballot was received, the Ballot Number, the voting dollar amount, whether the creditor
3 submitting the Ballot accepted or rejected the Plan.

4 12. For a Ballot to be counted as valid, the Ballot must have been properly completed
5 in accordance with the procedures set forth in the Disclosure Statement Order and executed by the
6 relevant Holder, or such Holder's authorized representative, and must have been received by
7 Stretto by no later than 10:00 p.m. (Pacific Time) on November 4, 2022 (the "Voting Deadline")³.

8 13. To the extent Active Members filed Proofs of Claim on or before November 4,
9 2022, and such Active Member's Ballot was received by Stretto end of day November 10, 2022,
such active member has been included in the tabulation results reported herein.

11 14. Stretto is in possession of the Ballots received by it, and copies of the same are
12 available for review during Stretto's normal business hours.

13 15. The results of the aforesaid tabulation of properly executed Ballots received by
14 Stretto on or before the Voting Deadline are set forth below and in the report annexed hereto as
15 **Exhibit A** (the "Final Tabulation Results").

16 16. In accordance with the Disclosure Statement Order, any Ballot submitted on behalf
17 of a claim under objection⁴⁵⁶⁷⁸ is included in Final Tabulation Results reflecting such objection.
