- 2. I am the attorney at BG primarily responsible for overseeing the billing in this matter and for assuring compliance with the Bankruptcy Rules, the Local Rules, and the guidelines from the United States Trustee ("US Trustee"). The facts set forth herein are based upon my personal knowledge, and, if called as a witness, I could and would testify competently thereto.
