I request your tolerance for my lack of legal skills in responding to yet another pile of legal documents delivered to my home.

The purpose of this filing is to object to the proposed reduction in my claim amount as found in Documents 558, 559 and 560 recently filed by the Debtor and his legal team.

The Debtor in this case is of questionable character, as can be attested to by the numerous emails sent to members promising goods and services for a set monetary investment which remain unfulfilled. I have attached copies of Exhibits A, B and C, which were included in my 410 Claim Form filing, of which Exhibit A is a prime example of these mailings.

In Exhibit A you will see wording that clearly states that the memberships are indeed mine, as well as the promise that the proceeds of the sale of my memberships would belong to me. You should also note the unfulfilled promise of promoting the sale of my memberships, which never occurred, even though I agreed to the terms and paid the money requested. (See Exhibit B)

The fact that the Debtor is in severe financial difficulty should also be considered in assessing the accuracy of the huge reductions recommended to the submitted claim amounts.

The number and value of the memberships cited in my 410 Claim submission were taken directly from the Front Sight Firearms Training website and therefore set by the Debtor himself. (See Exhibit C)

As the Pastor of a small church in Chino Valley, AZ, I am inclined to show compassion toward those who have, by their own actions, placed themselves in dire straights. To that end, I am willing to accept \$159,600.00, which is 25% of my submitted claim amount of \$638,400.00, to help bring this issue to a close.

I have filed this claim based upon what I believe to be a justifiable cause.

On January 26, 2022 I received one of many emails from Dr. Piazza concerning his financial troubles with Front Sight Firearms Training.

This particular email (attached Exhibit A) outlined an opportunity for members to retain control of their TBD (To be determined) memberships, sell them and keep the proceeds. The only requirement being that a \$500 membership fee must be paid within a stated time frame. [Please note that I highlighted in bold, green, underlined text the pertinent parts of the email and left off another page or two of repetitive and unrelated text.]

Knowing that I had a number of valuable memberships, I paid the \$500 required fee, immediately and received an email from Dr. Piazza with my Order number, receipt and personal thanks for contributing, dated January 26, 2022. (Attached Exhibit B)

A quick view of my Front Sight Assets page (attached Exhibit C) shows 8 Front Sight Founder memberships. The current value of each as displayed on the Front Sight Firearms Training website is \$60,000 (sixty thousand dollars). Thus a potential sales value of \$480,000 (four hundred eighty thousand dollars) that I secured via accepting Dr. Piazza's offer presented in Exhibit A.

The next item on my Assets page is Legacy Memberships. There are 16 of them with a current value listed on the Front Sight website of \$9,900 (nine thousand, nine hundred dollars) each, thus another \$158,400 (one hundred fifty eight thousand four hundred dollars) of potential sales value.

The above combined memberships value is the amount of the Claim entered on Form 410. Your consideration of my predicament is greatly appreciated.


