26 27	part on other grounds, 468 F.3d 592 (9th Cir. 2006); In re Ginji Corp., 117 B.R. 983, 990	
28	(Bankr. D. Nev. 1990) ("[t]he applicant has the burden of proof to show the reasonableness of	
	the fees sought").	

2. The United States Trustee has reached an agreement with Applicant to resolve the United States Trustee's informal objections to the Application prior to the above-captioned hearing. Applicant has consented to a voluntary reduction of \$74,698.92 to address the United States Trustee's informal objections to the Application. 3.
