	the fees sought").	

- 2. The United States Trustee has reached an agreement with Applicant to resolve the United States Trustee's informal objections to the Application prior to the above-captioned hearing. Applicant has consented to a voluntary reduction of \$14,039.30 to address the United States Trustee's informal objections to the Application.
