CHAPTER 11

**CLAIMANTS OBJECTION TO THE PROPOSED TREATMENT, REDUCING  
AND ALLOWING CLAIMANT'S CLAIM**

I, Peter Passaretti, am not a lawyer,

1. I am claimant number 64-1, claim submitted in the amount of \$3,444.00. I determined this amount based upon the Front sight myfrontsight.com website that documented and maintained the membership levels paid and achieved, it also provided an accounting of my bank of memberships and certificates available to me for sale as well as the Front sight dollars available for use in the Front sight store and for use at the Front sight resort property.

2. The Liquidating Trustee has determined that my claim should be reduced to \$2,144.00 based upon their evaluation of Front Sights account of payments received, however no documentary evidence was provided.

3. I have been a member since 2013, have been an Ambassador, Commander, Patron Plus, Heritage, Producer, Guardian, Director and possibly others – not necessarily in order.

My last payment to Front sight was December 2021, I have to believe on this date that Piazza and Front sight accountants, managers, and legal staff were already in preparations for the Bankruptcy filing in the spring of 2022. I was not informed of the impending bankruptcy nor the risks that would bring. I question the fraudulent solicitation of upgrades at that time.

At the time that my Front Sight order was being processed, I would receive the following:

- 1 x Front Sight Patronage Points, \$2,000
- 20 x Four Day Handgun, Shotgun or Rifle Course Certificates
- 20 x Front Sight Patriot Lifetime Memberships
- 1 x Custom, limited edition Front Sight, Special Member Status, folding knife
- 1 x Front Sight Warrior Electronic Hearing Protection with custom Front Sight Warrior case

None received!

4. The myfrontsight.com website is no longer online, thus I am not able to dispute any allegations. Neither have they provided any records or statements verifying the results of their efforts.

5. Front sight and the Trustee have placed no value on the many, dozens of memberships and certificates, that Piazza had valued at 10's of thousands of dollars, nor have they placed any value on the rewards, points, and Front sight Bucks in my account, neither have they supplied an accounting of such. Nor do the Trustees award any value for equipment's promised for prompt payments, such as pocket knives, ear Protection, etc.


6. The Front sight bankruptcy was completed at some \$19M, but does not account for the \$7M that Piazza will receive over 10 years, a total of \$26M.

There are many speculations that Piazza, et al are the financing and manipulators behind the Prairie Fire purchase of the Front Sight assets (see Facebook), this Court needs to assure the Claimants that this is not a circular effort to defraud the Claimants.

7. It is also incumbent on this Court to ensure the Claimants that Prairie Fire has the financial resources to continue to pursue the legal activities for this Bankruptcy, and that Prairie Fire has the financial wherewithal to continue the resort pursuits that Front Sight had started.

8. Piazza and LVDF have counterclaims of fraud against each other. Reading the submissions to this court, one can conclude both parties offer meritorious points, thus IMO neutralizing the bilateral arguments. The entire \$26M should be allocated to the members that invested into the development of the property.

9. I hereby request that this Court reinstate my original claim of \$3,444.00, any reduction in this amount must be validated with original accounting statements. I also request that this Court order full restitution in that amount.
