13 I Michel Deslauriers, am not a lawyer,

14 1. I am claimant number 82-1, claim submitted in the amount of \$4,410.00. This
15 amount was determined through documents that was available on the Front sight
16 membership page under my membership , and also through copies of emails between
17 me and Front sight management regarding my membership payments, balance and
18 proof of payments, presented with my claim.

19 2. At this point Front sight and the liquidating Trustee isn't even arguing that I
20 paid for a lifetime membership. They claim that I have received a refund for
21 my membership in the amount of \$2,891.00. They also claim that this is
22 reflected in the Debtor's books and records.


23 3. At the beginning of June 2022, I started noticing that my access to the
24 membership page of Front Sight was blocked. I tried reaching out the Front
25 sight management and the help desk without any success and answers from Front
26 Sight. On june 7th 2022 I sent an email to Front Sight (a copy is included
27 here) management and asked them issue me a refund of the total amount payed for
28 my membership (\$4,4100.00) as it seemed that my membership had been blocked.

1 Again I never received any answer from anyone From Front Sight. And I certainly
2 never received any form of refund from Front Sight.

3 4. I request that Front sight and the liquidating Trustee present the pertaining
4 documents regarding my refund as they claim. For example, if they sent a check
5 under my name at my address, they should be able to present proof that this was
6 sent (copy of the check, its number, date it was issued) and also that the
7 check was cashed in and with my signature. They can easily go through Front
8 sight's bank and have the original check and the receipient's signature also.
9 May it please the court, the signature can also be verified with my own , found
10 here at the bottom of this document. As you will see that Front sight and the
11 liquidating Trustee cannot issue any proof that a check was sent and cashed in
12 from me for the amount of \$2,891.00, I request that a new one be issued and
13 sent to me at the same amount so that Front sight and the liquidating Trustee
14 honour the payment that they had accepted to pay me as found in the NINTH
15 OMNIBUS OBJECTION REDUCING MEMBER CLAIMS AND DISALLOWING AND EXPUNGING CERTAIN
16 OTHER MEMBER CLAIMS, page 13.
