AMENDMENT TO MY OBJECTION

I Michel Deslauriers am not a lawyer,


1. I am claimant number 82-1, claim submitted in the amount of \$4,410.00. When I submitted my proof of claim, I had submitted also proof of payment to Front sight for my life membership, also a copy of my membership page found on the Front sight webpage membership information. At my previous amendment to my objection, I stated that I never received any refund from Front Sight at any amount. This remains true. Susan K. Seflin from the liquidating Trustee claims not to have any records of me paying more than \$2,891. They also claim I did not attach any evidence to the proof of claim, which I did in the form of an email from Ignatius Piazza dated from December 5 2013, stating the payement agreement of 90 payments of \$49, with a balance of of \$1,519 on that date, with a last payment to be withheld by 7/01/2016 as explained by Mr Piazza.
2. I found a previous email from Mr. Jon Landwer , the corporate operations manager of Front sight dated form December 4<sup>th</sup> 20113 ( found here ) stating the same thing but also showing the date where the payment agreement started (beginning of my life membership) whereas 02/09/2011.
3. Another email that I had found and sent through my previous amendment from Mr Piazza. As per Ignatius Piazza's email sent to me on November 28 2014 (which I found and sent you with my previous amendment to my objection), he explains that my balance was then \$400. Mr. Piazza authorized me to make a last lump-sum payment of 280\$, which after reading back this email, and my response, I did, in the form of 280\$, thus paying off the balance of my membership with a last payment with a 30% discount. So although my membership price was \$4,410.00 by reading the found emails I sent you on my previous amendment, my total claim



1 has to be reduced then by \$120 which is the difference between the balance  
2 owned on November 2014 (\$400) and the reduced 30% discount authorized by Mr.  
3 Piazza for my last sump-sum payment. In total, my claim has to be reduced to  
4 \$4,290.00. Please accept my apologies but these last emails are almost 10 years  
5 old and where not easy to find.

6 4. As per emails included all here from Susan K. Seflin from the liquidating  
7 Trustee claims, she states that I am lying ( as proof I only have emails from  
8 Front sight)and that Front Sight refunded me \$2,891.00 which I stated never  
9 received. However, she was willing to give me an unsecure claim for this amount  
10 (see-attached emails). As I refused, she went on then saying that she will go  
11 on disallowing all of my claim as she states that she has proof that I received  
12 a refund (I've been asking for this proof since the beginning), and later on  
13 stated that I was banned from Front sight (I didn't receive anything for that  
14 matter) and thus cannot receive anything. The whole conversation with this  
15 lawyer was confusing and unreal.
