Hale [ECF 17 No. 787], Claim 1059-1 is allowed as a GENERAL UNSECURED CLAIM in the amount of 18 \$7,500.00 and disallowed to the extent that it asserts any amount over \$7,500.00. 19

**IT IS HEREBY FURTHER ORDERED** that pursuant to the Order Approving Stipulation 20 Resolving Twelfth Omnibus Objection as it Relates to Claim 1065-1 filed by Robert M. Lippmann 21 [ECF No. 798], Claim 1065-1 is allowed as a GENERAL UNSECURED CLAIM in the amount of 22 \$5,000.00. 23
