 20 **DESCRIBING DEBTOR’S CHAPTER 11 PLAN OF REORGANIZATION**

21 **PLEASE TAKE NOTICE** that concurrently with the filing of this notice (“Notice”), Front
 22 Sight Management LLC, the chapter 11 debtor in possession herein (the “Debtor”), has filed an
 23 application for an order shortening time (“OST App”) so that a hearing will be held on **September**
 24 **30, 2022 at 9:30 a.m.** before the Honorable August Landis, Chief United States Bankruptcy Judge,
 25 in his Courtroom 1 located at 300 Las Vegas Blvd. South, Las Vegas, Nevada 89101, via ZoomGov,
 26 for the Court to consider the adequacy of the Debtor’s first amended disclosure statement [ECF No.
 27 338] (“Disclosure Statement”) describing the Debtor’s first amended chapter 11 plan of
 28

1 reorganization [ECF No. 337]. A hearing on a previous version of the Disclosure Statement was
2 originally scheduled for September 23, 2022 at 9:30 a.m. (and now is off calendar), and the Debtor
3 expects that the hearing on approval of the adequacy of the Disclosure Statement will be held on
4 **September 30, 2022 at 9:30 a.m.** (subject to the Court's approval of the aforementioned OST App).

5 **PLEASE TAKE FURTHER NOTICE** that pursuant to the OST App, the Debtor is seeking
6 a hearing on shortened time regarding Court approval of the Disclosure Statement, and is requesting
7 that the Court **set September 23, 2022 as the deadline to object to the Disclosure Statement.** You
8 will receive a copy of the order on the OST App once it has been entered by the Court.

9 **PLEASE TAKE FURTHER NOTICE THAT** copies of the Plan and Disclosure Statement
10 (and any amendments thereto) may be obtained from the above-captioned Court, located at the Foley
11 Federal Building, 300 Las Vegas Blvd. South, Las Vegas, Nevada 89101, through the Court's
12 electronic filing system (<https://ecf.nvb.uscourts.gov/>), for free via the Debtor's noticing agent at
13 <https://cases.stretto.com/FrontSight> or by sending a written request to counsel for the Debtor, Susan
14 K. Seflin, via email at sseflin@bg.law.

16 If you object to the relief requested, you *must* file a **WRITTEN** response to the adequacy of
17 the Disclosure Statement with the Court. You *must* also serve your written response on the
18 person who sent you this notice.

19 If you do not file a written response with the Court, or if you do not serve your written
20 response on the person who sent you this notice, then:

- 21 • The Court may *refuse to allow you to speak* at the scheduled hearing; and
- 22 • The Court may *rule against you* without formally calling the matter at the hearing.
