20 NOTICE IS HEREBY GIVEN that as of December 2, 2022, all conditions precedent to the

3 NOTICE IS FURTHER GIVEN that as a result of the occurrence of the Effective Date, the
4 Administrative Claims Bar Date for filing applications for allowance of Administrative Claims shall
5 be **January 3, 2023**. The failure to file an application for the allowance of an Administrative Claim
6 by the Administrative Claims Bar Date shall result in such claim being forever barred.

7 NOTICE IS FURTHER GIVEN that as a result of the occurrence of the Effective Date, the
8 deadline for filing Professional Fee Claims for services rendered before the Effective Date shall be
9 **January 3, 2023** (the “**Professional Compensation Bar Date**”). The failure to file an application
10 for the allowance of Professional Compensation by the Professional Compensation Bar Date shall
11 result in such claim being forever barred.

12 NOTICE IS FURTHER GIVEN that as a result of the occurrence of the Effective Date, the
13 deadline for filing objections (each an “**Objection**”) to Claims (the “**Claim Objection Deadline**”)
14 shall be **February 28, 2023**.

15 NOTICE IS FURTHER GIVEN that the deadline for Members to file proofs of claims for
16 claims arising out of the rejection of their memberships shall be **January 3, 2023** (the
17 “**Membership Rejection Claim Bar Date**”). The failure to file a proof of claim for a claim arising
18 out of the rejection of a membership by the Membership Rejection Claim Bar Date shall result in
19 such claim being forever barred.
