Dear Trust Beneficiary:

As you are aware, Front Sight Management LLC filed chapter 11 bankruptcy petitions on May 24, 2022. On October 3, 2022, the Bankruptcy Court entered an order confirming the *Second Amended Chapter 11 Plan of Reorganization* (the “Plan”). On November 18, 2022, the Bankruptcy Court entered an order confirming the *Stipulation Resolving the Committee’s Objection to Plan Confirmation and Modifying Debtor’s Second Amended Plan* (the “Modification Order”), which was approved pursuant to Bankruptcy Court order entered on November 21, 2022. On November 29, 2022, the Bankruptcy Court entered an order confirming the Plan (“Confirmation Order”) which, among other things, approved the appointment of Province, LLC as the Liquidating Trustee of the Front Sight Creditors Trust (the “Trust”). On December 1, 2022, the Effective Date of the Plan occurred (“Effective Date”).

The Trust is a liquidating grantor trust established to liquidate those assets conveyed to the Trust pursuant to the Plan, in addition to making any and all Distributions provided for in the Plan to the Beneficiaries of the Trust.

In April 2024, the Trust made a first and final distribution to Beneficiaries.

Pursuant to the Plan, Beneficiaries are treated as grantors of the Trust for federal income tax purposes. As such, please find enclosed your respective **final** grantor letter. **Please consult your tax advisor for proper tax treatment.**

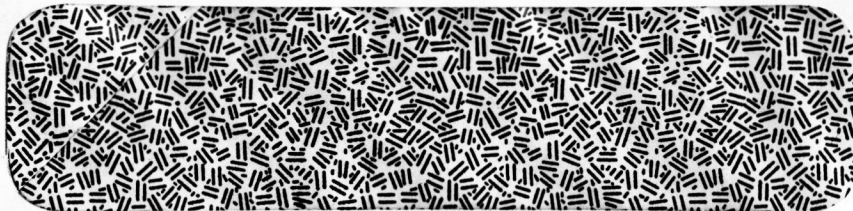
